NEWS FROM THE MEMBERSHIP RECORD KEEPER.

As of the writing of this note, end of March 2017, I show 240 paid members for 2016, and 54 paid members already for 2017. YEAAA!!!

But there has been a little confusion as to whether a member is paid up to date with their dues.

Remember the year runs from June 1st to May 31st.

- If you pay during this time period, the dollars will be applied to the current year dues.
- If records show the member is paid up for current year, and you indicate for next year's dues, the amount will be applied to the next year dues.
- If no extra year(s) is indicated on form or check, extra amount will be applied to general donation or bog fund for current year.

One Example: If you were a paid member in 2015, (dues were \$25) and you sent a check for \$50 in fall 2016 or Jan, Feb, Mar 2017, it was applied this way, \$25 for 2016 dues and \$25 for only half of 2017 dues. One cannot skip a year, but now, one is a half year behind. I will not split a year from now on. It will be applied as indicated with bullet points above.

Increase of dues to \$50 was voted and approved upon by membership at May 2016 annual meeting for year starting in June 2017.

Having the membership form filled out is wonderful, that is our second line of accuracy for records. If you are unsure as to your membership status please call 320-859-7609 I will be glad to check the membership list and let you know your status. I also will have records at the May meeting and can answer your question then.
